INFORMATION FOR AUTHORS

Papers submitted to the journal "Mongolica", must be formatted as follows.

Information about the author(s)

First name Last name

academic degree, academic title (if the author has any),

position, department (faculty, laboratory, etc.), name of the organization (in brackets — postal address of the organization including postal code),

e-mail

If there are two or more authors, they should be listed one by one after a blank line.

Title of the Article

Alignment: center

Font: Times New Roman, bold, type size: 14

Abstract and keywords

Alignment: left

Font: Times New Roman, type size: 12

The abstract should be at least 700 characters long.

Not more than 5 keywords must be used.

Text of the Article

Alignment: left

Font Times New Roman, type size: 12, line spacing: 1.5, paragraph indention: 0.75 cm.

References in square brackets: last name of the author, year of publication, pages of the cited place.

Example: [Erdal, 2004. P. 183]

Footnotes if used, must be situated at the bottom of page.

References

The list must include only the literature that is referenced in the text of the article, and must be arranged in alphabetical order.

The order of reference: author's last name, comma, year, colon, author's last name, initials (in italics), title of the work, place of publication, year of publication.

Names of works written in Asian and African languages, as well as written in Cyrillic must be transliterated in Latin and have an English translation.

Example:

Bacharach 1975: Bacharach J. L. Circassian Mamluk Historians and their Quantitative Economic Data. Journal of the American Research Center in Egypt. Vol. 12 (1975). P. 75–87.
